Understanding Your Rights as a Debtor

- Your signature

What to Do If Debt Collectors Ignore Your Request

If a debt collector continues to contact you after receiving your written request to stop calling, they are in violation of the FDCPA. This violation can have significant consequences for the collection agency. You have the right to take legal action against them for failing to comply with your lawful

request. It is important to meticulously document every instance of contact after you have sent your cease and desist letter.

Keep a detailed log of all calls, including the date, time, name of the collector, and the content of the conversation. Save any voicemails or letters you receive. This documentation will serve as crucial evidence if you decide to pursue legal recourse. You may be able to sue the debt collector for damages, including statutory damages and attorney fees, depending on the severity of the violations.

Consider the following steps if your request is ignored:

- Continue to document all contact attempts.
- Review your documentation for any FDCPA violations beyond the continued calls.
- Consult with a consumer protection attorney specializing in debt collection matters.
- Consider filing a complaint with the Consumer Financial Protection Bureau (CFPB) or your state's Attorney General's office.

How to Deal with Debt Collection Calls Legally

Beyond sending a cease and desist letter, there are other legal avenues and strategies to manage debt collection calls.
