#### What is Dropshipping Income Tax?

This \$3,000 would then be the amount of income you report and pay taxes on, according to your individual income tax bracket or your business's corporate tax rate.

#### **Understanding Sales Tax for Dropshippers**

Sales tax is collected from the end consumer at the point of sale and remitted to the relevant state government.
